Old Senate Chamber on the second floor of the Nevada State Capital pursuant to NRS 331.133. These funds will be held in the Treasurer's Office and expended out of B/A 5036, category 55. Requires Board approval pursuant to NRS 381.0075. Pete Dubé made the motion to accept. Member Diamond seconded. Approved without dissent. (10a1)
- 40. The Chair took Item 10a2, Restricted Funds/Donation Received. Discussion and action to accept restricted funds in the amount of \$700 from Robert "Bob" Stoldal for the Nevada State Museum, Las Vegas library fund. These funds will be held in the State Treasurer's Office and expended out of B/A 5039, category 55. Requires Board approval pursuant to NRS 381.0075. Anthony Timmons made the motion to accept. Member Dubé seconded. Motion carried without dissent. The Chair abstained from the vote. (10a2)

Offset in category 55, Restricted Special Projects by a like amount (\$700,000). Pete Dubé made the motion to approve. Member Timmons seconded. Approved without dissent. (10c1)
- 46. The Chair took Item 10c2, Changes requested from the Board over \$5,000. Request to increase authority in Budget Account 5035, Nevada Historical Society increasing RGL 4265, Private Grant in the amount of \$2,107,162 to reflect anticipated proceeds from the David J. Tacchino Trust. Funds would support several projects identified by the donor. Offset in category 55, Restricted Special Projects by the like amount (\$2,107,162). Pete Dubé made the motion to approve. Member Diamond seconded. One opposed, motion carried. (10c2)

Request to increase authority in Budget Account 5037a, Nevada State Railroad Museum, Carson City, RGL4251 Gifts and Donations by \$68,112 for an unrestricted bequest from the Vera Silberstein Gift Trust.
