- 3. Chris Stanko of Maupin, Cox and LeGoy representing the Northern Nevada Railway Foundation introduced himself during public comment. (4)

- 4. The Chair took Item 5a, Acceptance of the Minutes for June 15, 2017. Dr. Barber made the motion to approve the amended minutes for June 15, 2017. Member Dubé seconded. Motion carried without dissent. (5a)
- 5. The Chair took Item 5b, Acceptance of the Minutes for June16, 2017. Dr. Dwyer made the motion to accept the minutes for June 16, 2017. Member Barber seconded. Motion carried without dissent. (5b)
- 6. The Chair took Item 6b, Calendar for Next Meeting. Pete Dubé made the motion for the next meeting be conducted March 9, 2018 at the Stewart Indian School in Carson City. Member Cowie seconded. Motion carried without dissent. (6b)
