- a) Discussion and possible Board action to approve a contract for services of an independent contractor with Sheridan Press, Hanover, PA, in the amount of \$8,445.82 for publication of two issues of the Nevada Historical Society *Quarterly.* (For Possible Action)

Fee increase proposed is \$2.00 per adult for the premium services provided. Additional revenue generated would post to General fund. Pursuant to authority under NRS 381.0045. (For Possible Action)
  - b) Request to modify revenue distribution into Category 56, Restricted Collection Storage Maintenance collected under RGL # 3871 Anthropology Fees. Presently, 50% of all funds received in this revenue source are restricted for future needs in Category 56 for collection storage maintenance and, new for this fiscal year, fees received by BLM for curation assistance are now recognized under this revenue source. This request increases the restricted amount to 75% of that revenue received to be placed for expenditure in Category 56 and also requests amendment of the intent of the expenditure category. Currently the category has restricted use for necessary collection resource management supplies, equipment and infrastructure as needed. The amendment requests to also add curation of cultural resource management as was the case in previous fiscal years under the BLM curation agreement. This would allow for the hiring of temporary labor to assist with collection processing and management with the added benefit of support for all collection management, not just that received through BLM collections.   - 1. Nevada State Museum, Carson City, request for Category 48 funding authority in the amount of \$6,800 for procurement of software services from Offero for volunteer and tour management.
  - 2. Nevada State Railroad Museum, Carson City, request for Category 48 funding authority in the amount of \$2,663.75 for the museum director to attend the Association for Living History, Farm and Agricultural Museums conference in June 2020.

  - 1. Request to increase authority in BA 5033, Receipts from Outside Bank Account, RGL 4454 by \$5,000 to a new adjusted budget amount of \$26,649. This is offset by the establishment of a new category, category 37, to fund professional development. This action follows direction from the Board at the June 2019 meeting.
  - 2. Request to increase authority in BA 5036, under RGL # 3871 by \$60,000 to a new adjusted budget amount of \$120,000. This represents added Anthropology Fee revenue and is offset in category 48, Board Approved Special Projects, by \$15,000 and category 56, Restricted Collection Storage Maintenance/Management by \$45,000. (This represents the 75%/25% split if approved in item 9(a)2(b).

3. Request to increase authority in BA 5038, RGL 4454, Outside Bank Account by \$59,086 to an adjusted amount of \$59,086. This to fund a compact storage project offset in category 38, "Shelving Unit Project" by \$59,086 based on vendor design and cost quote.

Funds to be deposited in the State Treasurer's Office and expended out of B/A 5036, Category 55, RGL 3608. Requires Board approval pursuant to NRS 381.0075.
- e) Discussion and action to accept restricted funds in the amount of \$5,000 from Ranee Barsanti and Jessica Ledbetter for the Nevada Historical Society's Collections Fund. Funds to be deposited in the State Treasurer's Office and expended out of B/A 5035, RGL 3022. Requires Board approval pursuant to NRS 381.0075.
- f) Discussion and action to accept restricted funds in the amount of \$500 from Ranee Barsanti and Jessica Ledbetter for the Nevada Historical Society's Conservation Fund.
