  - Request for budget change in BA 5036, Nevada State Museum to increase authority in category 49, museum store by an additional \$5,000, and category 86, reserve by an additional \$49,576 to reflect higher than anticipated activity in Coin Press, memberships and store sales. Offset by an increase in RGL 3872 (Coin Press) of \$25,036; RGL 4008 (memberships) of \$9,540 and RGL 4025 (store sales) of \$10,000.
