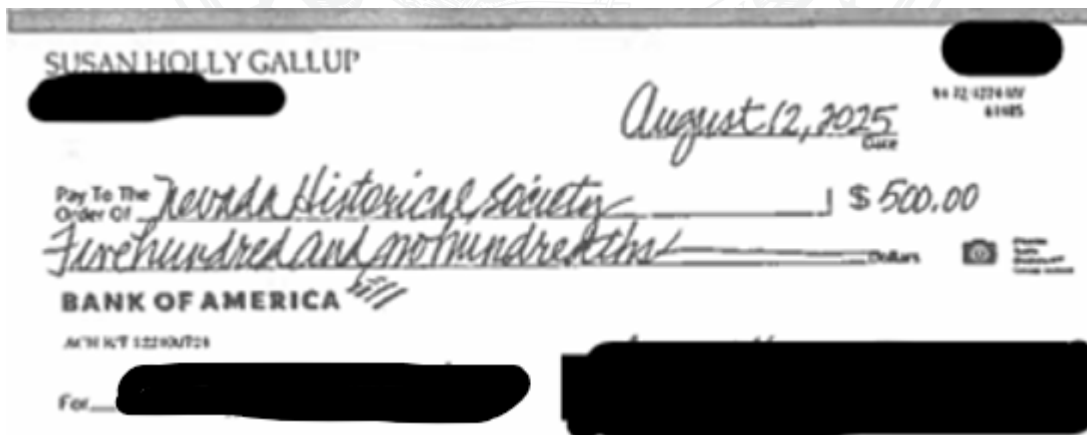

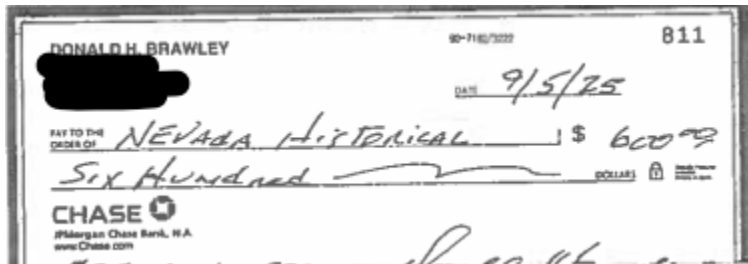

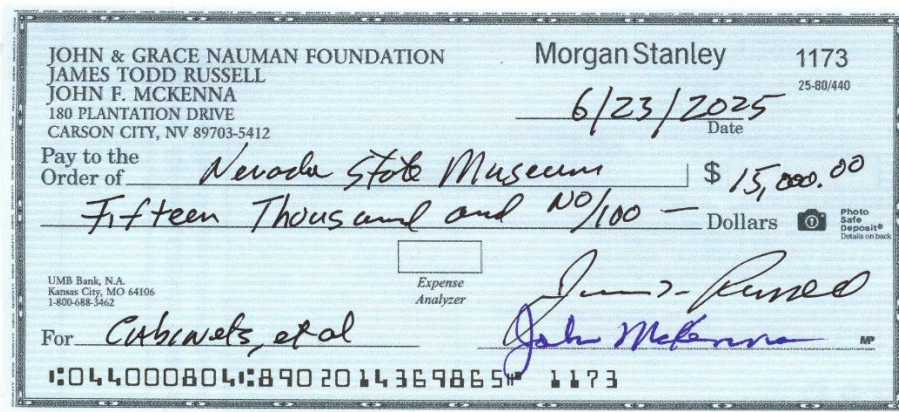


Figure 1 – Check No. 1173 in the amount of \$15,000 made out to the Nevada State Museum

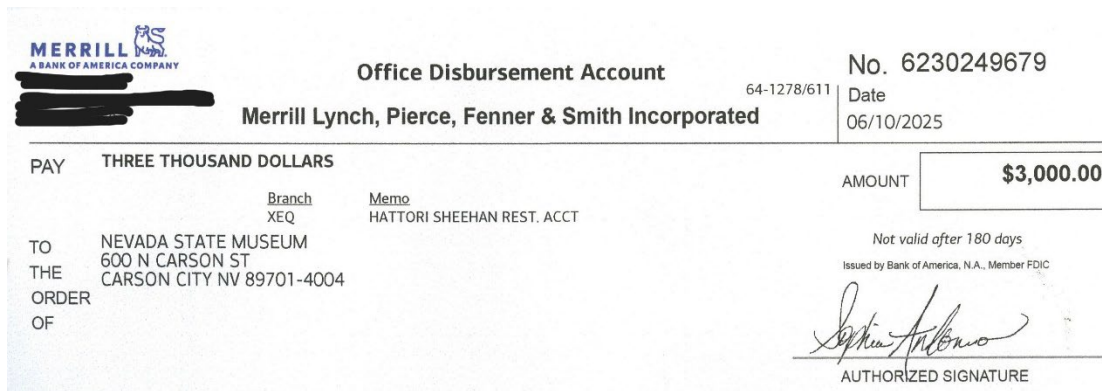


Figure 1 – Check No. 6230249679 in the amount of \$3,000 made out to the Nevada State Museum

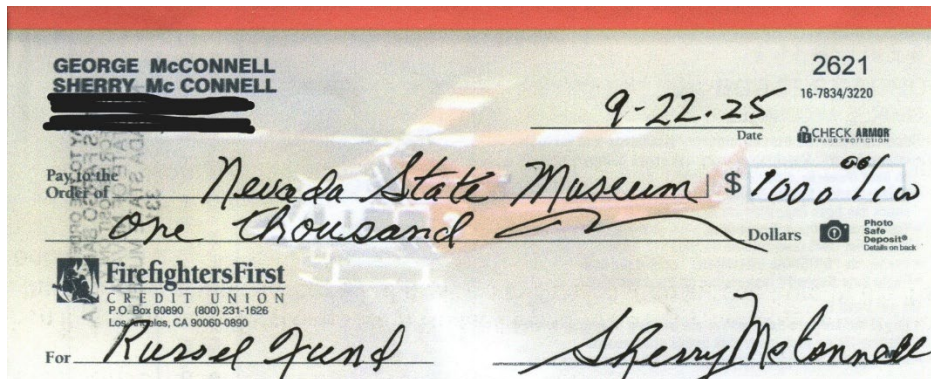


Figure 1 – Check No. 2621 in the amount of \$1,000 made out to the Nevada State Museum

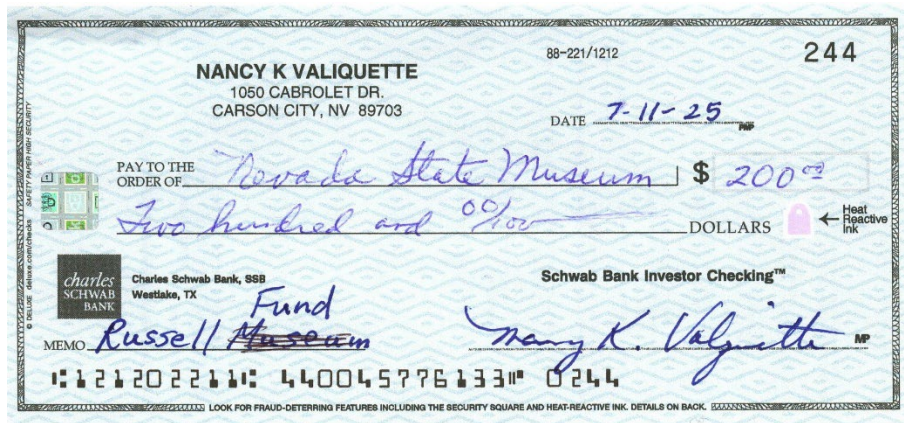


Figure 1 – Check No. 244 in the amount of \$200 made out to the Nevada State Museum

I would like to request \$5,000 in additional spending to be granted to fund merchandise inventory purchases for the Nevada State Museum, Las Vegas Museum Store. This additional authority would be used to purchase merchandise specifically in support of our next changing exhibit in celebration of America 250.

**Justification:**

· Our next original exhibit in our changing gallery: *Setting the Stage: In the Footsteps of Dominguez and Escalante*. This exhibit will honor the United States Semi quincentennial. Opening May 23, 2026- April 2027

The store would like to purchase merchandise in direct support of the exhibit. The store’s initial spending authority of \$46,430.00 for FY26 should be sufficient to keep a healthy inventory of regularly purchased items through the end of the fiscal year, *but* it is not enough to cover any additional spending on special exhibit merchandise.

· As an example of anticipated sales, for the Old Spanish Trail exhibit in 2024, the store purchased \$3155.72 in exhibit specific merchandise and made \$7321.20 in sales on that merchandise, a 56.90% gross profit margin. The store’s average profit margin for FY 26 so far is 61.7%. We are confident that the merchandise purchased for *Setting the Stage: In the Footsteps of Dominguez and Escalante* exhibit would realistically return at least a 60% margin.

Lost City Museum recently has been presented with an opportunity to sell higher end consignment items in the museum store. Currently the museum store only has \$3,000.00 allocated for consignment. If the consignment items don't sell, they will go back to their respective owners vs. us having to keep them until we can. We feel having an additional \$20,000.00 funds would be beneficial to this possible consignment arrangement.
