# Board of Museums and History December 5, 2025 Staff Report November 21, 2025

#### NRHP or SRHP Listed Nominations

Amity Lodge No. 4. (SRIS 250164) 175 Main Street, in Silver City, Lyon County (listed). The property was approved for listing in the State Register of Historic Places, during the June 5, 2025 Board of Museums and History meeting in Las Vegas. The listing was signed by SHPO Arthur Krupicz on June 18, 2025. Per the Board's request, the final copy of the updated nomination was emailed to the Board on July 21, 2025.

### NRHP or SRHP Pending Nominations

<u>Las Vegas Mormon Fort (NRIS 72000764)</u>, <u>Las Vegas, Clark County (Additional Documentation)</u>.

The City of Las Vegas seeks to amend in the National Register of Historic Places the existing listing of the Las Vegas Mormon Fort, located at 500 E. Washinton Avenue, Las Vegas. The Old Las Vegas Mormon Fort is a Nevada State Park located in a developed urban area of Las Vegas. It consists of a large, open area anchored by an original adobe building as well as a partial reconstruction of the 1855 fort's walls and northwest bastion. It was previously listed in the National Register of Historic Places in 1972, and the boundary was increased in 1978. The current amendment now before the board is providing additional documentation that establishes a period of significance, applicable criteria, updated site description and inventory, and additional historical information and significance of the property. It is recommended significant under Criterion A, D, with Criteria Consideration E.

### Bethel AME Parsonage, Reno, Washoe County (new nomination).

The City of Reno seeks to list in the National Register of Historic Places the Bethel AME Parsonage, located at 411 E. Seventh Street, Reno. The Bethel AME Parsonage is eligible for listing under Criterion A under the themes of Social History and Ethnic Heritage: Black for its significance at the local level as the parsonage for Reno's Bethel AME Church (NRIS 1000587) from 1955 to 1975. Many of the ministers who lived in the house were not only religious leaders but played leading roles in Nevada's Civil Rights movement.

There are no pending SRHP nominations for this board meeting.

#### **NRHP Future Nominations and Modifications**

### E. Fourth Street Historic District, Reno, Washoe County (new nomination).

The City of Reno seeks to list in the National Register of Historic Places the E. Fourth Street Historic District (Reno). The proposed district is centered around E. Fourth Street, a major transportation corridor in east-central Reno that developed from 1900 and became a Lincoln Highway segment in 1913 and cosigned as the Lincoln/Victory Highway in 1921. The district's period of significance runs from 1900 to 1974. The E. Fourth Street Historic District is locally significant under Criterion A in the areas of Transportation, Commerce, and Industry as a transportation corridor that shaped Reno's industrial, commercial, and tourist activities in the early to mid-twentieth century. Commercial and industrial enterprises along the corridor were diverse, including breweries, lumber yards, warehouses, motels, restaurants and bars, grocery and liquor wholesalers, and automobile shops. The district is home to some of Reno's most remarkable early twentieth-century buildings. This nomination may be reviewed by the Board during the March 2026 meeting.

### <u>Downtown Winnemucca Historic District, Winnemucca, Humboldt County (new nomination).</u>

The city of Winnemucca seeks to list in the National Register of Historic Places the Downtown Winnemucca Historic District. Downtown Winnemucca Historic District is locally significant under Criterion A in the areas of Commerce and Community Planning and Development, with period of significance that runs from 1866 to 1968. During this time period, the district served as one of the town's primary commercial hubs, as well as an anchor of community life, with civic buildings such as the post office and library, shops, banks, bars, restaurants, and social spaces including a theater and a church. The district contains 60 resources, with a wide mix of property types, styles, and construction dates that clearly illustrate downtown Winnemucca's development and use patterns over the historic period. With 65% of the district resources contributing, the district retains sufficient overall integrity to convey its significance. This nomination may be reviewed by the Board during the March 2026 meeting.

#### **SRHP Future Nominations and Modifications**

### Log Cabin Bar, Hawthorne, Mineral County (new nomination).

The owner seeks to list in the State Register of Historic Places the Log Cabin Bar, Hawthorne, Mineral County. It is significant under Criterion C in the area of distinctive types of architecture significant to Nevada. Built in 1949, it is an example of programmatic architecture of the "log cabin" style, popularized in the 1930s. Its period of significance is 1949 to 1978.

# Florence Crittendon Home, Reno, Washoe County (new nomination).

The City of Reno seeks to list in the State Register of Historic Places the Florence Crittendon Home, located at 781 Mill Street in Reno, Washoe County. The Florence Crittendon Home is eligible for listing in the State of Nevada Register of Historic Places under Criteria A, for its significance in Social History under the theme of Women's History. Its period of significance is 1919 to 1930.
